7/19/22 Angela and I had a discussion with Kathy Spencer from LaBella (engineering firm) regarding the contract to represent us through the Terra-Gen windfarm project.

7/21/22 Jeanette and I attended a NYGFOA seminar in Batavia that discussed the rules for spending and reporting the ARPA funds that the town applied for and received.

7/25/22 I have been working for the last couple of weeks with Kathy Spencer (LaBella) on a contract for LaBella to represent Prattsburgh regarding the Terra-Gen project.

7/26/22 We signed a contract with LaBella Engineering to review and comment to the board as the Terra-Gen project moves forward. They will be requesting and reviewing updated documentation on local laws, environmental studies, Host Community Agreement, Road Use Agreement, etc. We have money in escrow provided by Terra-Gen to fund this effort.

7/26/22 The environmental review for the Main Street Grant has been completed and submitted for review to OCR (Office Community Renewal). If they give the thumbs up Chris Costanza will be able to start the renovation of his property using the funds from the grant.

7/28/22Leonard Carruthers (Steuben Foods) dropped of the paper work from the D.E.C. giving the milk plant site a clean bill of health.

8/1/22 Chris Underhill and I met with Marcus Anten (Ti Sales). Ti Sales represents a line of products manufactured by Neptune that support water districts. Our current supplier (Badger) no longer supports our meters or software, so we have to make a transition to another system.

8/8/22 Chris Underhill and I met to discuss which manufacturer to purchase the new software and water meters. We have decided to go with Neptune for a number of reasons. First, Neptune designs and manufactures all of their products in the U.S. Second, Neptune warranties their product for twenty years unlike our current supplier who no longer supports our system after only ten years. Third, Naples chose Neptune and they are very satisfied with the product and service. Naples and Prattsburgh can partner if either of us need a part or help in resolving a problem. We were able to negotiate the best price from Neptune.

8/9/22 I met with Jason Bellis and Allison Robbie (Larson Engineering) to discuss the Engineering Reports for the water department and the waste water project. They presented a quote for the P.E.R. (Preliminary Engineering Report) for the wastewater project. The P.E.R. for the water department will be presented at the August town board meeting. 8/10/22 Russ Kopylczak has completed the concrete, railing, and deck repairs to the town hall.

CONSIDERATIONS FOR USE OF ARPA (AMERICAN RESCUE PLAN ACT) FUNDS RECEIVED UNDER COVID 19

WHEREAS, the American Rescue Plan Act ("ARPA") of 2021, HR 319, otherwise known as the COVID-19 Stimulus Package or America Rescue Plan, was published L #117-2 on March 11, 2021. The plan provided \$1.9 trillion dollars of economic stimulus to speed up the country's economic recovery and health effects of the COVID_19 pandemic. This package builds upon many of the measures of the CARES ACT from March 2020 and in the Consolidated Appropriations Act of 2021.

WHEREAS, each municipality in the United States was provided an opportunity to receive funds related to COVID-19 recovery upon completion and submittal of said request by July 9, 2021. The Town of Prattsburgh opted to receive said funds under the definition of a NEU (Non Entitlement Unit), defined by section 603 (g)(5) of the Social Security Act, as added by Section 9901 of the American Rescue Plan Act of 2021, with NEU defined as a local government that serves a population of 50,000 or less. The ARPA funds are distributed in two increments. \$99,746.31 was the initial payment received in the summer of 2021, a subsequent summer 2021 payment of \$407.24 and a final payment of \$100,153.54 is anticipated for receipt in the spring of 2022, for a total of \$200,307.09. The Town of Prattsburgh has signed for compliance for Assurances of Compliance with Civil Rights Requirements as per Title VI of the Civil Rights Act of 1964. The agreement for said funds recognizes the criteria on the use of these funds which are outlined in the United States Department of Treasury final documents released April 1, 2022. All ARPA funds must be obligated by December 31, 2024 with full spending by December 31, 2026. A Federal Audit upon conclusion is anticipated.

WHEREAS, the Town Board of the Town of Prattsburgh has duly scheduled, noticed and held a Public Hearing on August 15, 2022 at the Town Hall to engage the community in potential projects which may be eligible for said funds under the Final Rule Regulations of the US Department of Treasury.

WHEREAS, the Town Board heard public comment on the issue as well as comments from Town Board members.

NOW THEREFORE BE IT RESOLVED that the Town Board of the Town of

Prattsburgh will consider such comments in determining the application of the ARPA Funds for approved uses of such funds.
